- 1 Mr. Abdur Rahim is the owner of a land situated in Chattogram District, Police Station and Sub-Registrar office- Haliashahar, Mouza- Kattali, CS. Khatian No.-25, RS. Khatian No.-35, SA. Khatian No.- 42, CS Dag No.-32, RS Dag N0-28, SA Dag No.-23, land measuring 45 decimils. Abul Kalam tried to dispossess his from the property illegally. Suppose you are a lawyer of Mr. Abdur Rahim, draft a plaint for permanent injunction in favour of Abdur Rahim. 10
- 2 Mr. Karim is the owner of a land situated in Chattogram District, Police Station and Sub-Registrar office- Pahartali, Mouza- North Pahartali, CS. Khatian No.-50, RS. Khatian No.-45, SA. Khatian No.- 48, CS Dag No.-35, RS Dag N0-38, SA Dag No.-33, land measuring 15 decimils. Mr. Rafique neighbor of Karim disposed him from the property on 15th September, 2019 forcibly and unlawfully without his consent. Suppose you are a lawyer of Mr. Karim, draft a plaint for recovery of khass possession under section 9 of the Specific Relief Act, 1877. 10
- 3 Mr. Arman died on 25th September, 2019 leaving wife Reshada Begum and two sons Arif and Asif and two daughters Salma and Samira. He had Tk. 50,00000/= in Eastern Bank Ltd. Agrabad Branch, Chattogram. Draft a petition of succession certificate for the heirs of Mr. Arman. 10
- 4 Draft a petition for amendment of pleading filed under Order-VI, Rule-17 of the Code of Civil Procedure, 1908. 10
- 5 Draft a naraji petition against police investigation. 10
- 6 Abdur Rahim manager of "Sunflower Insurance Company Ltd." of Agrabad Branch, Chattogram, proposed Abdur Karim to give him a suitable job and for this he demanded from Abdur Karim TK.2,00000/= (Two Lac) as the security money for the job. In the presence of the three witnesses Abdur Karim paid the money to Abdur Rahim. The condition was that Abdur Rahim will give the job to Abdur Karim within three months from the date of payment of money. But one year has passed Abdur Rahim neither giving the job nor returning the money rather he threatened and show fear to Abdur Karim. Now draft a complaint registrar (C.R) case under sections 406 and 420 Of the Penal Code, 1860 for Abdur Karim. 10
- 7 Majeda Begum married Abul Kalam on 10.05.2012. They have a son of 6 years and a daughter of 4 years. On 25th September, 2019 about 10:30 am, Abul Kalam demanded TK. 1,00000/= (One Lac) as dowry when Majeda Begum denied to give dowry he attacked to her with a rod and caused serious injury to the right side of her head. Draft a petition for compensation under section 11(C) of the Nari-O-Shishu Nirjatan Daman Ain 2000 (Amendment 2003). 10
